These options are not only convenient, they save money by eliminating the cost of stamps, envelopes, and time.

The association relies on the income generated from assessments paid by homeowners and dividends earned on our reserve savings. Your prompt payment allows us to operate more cost-effectively.

The Board has approved an operating budget which allowed the assessments to remain unchanged this year.

Annual income budgeted for 2008 is \$125,707.

Operating expenses are budgeted at \$83,050. Expenses include:

\$29,800 for landscaping, grounds and maintenance of common areas;

\$20,400 for Priestley Management, our property manager;

\$18,000 for electricity;

\$8,300 for office supplies, Community Watch and resident activities;

\$4,000 for insurance; and

\$2,550 for taxes, accounting services and legal fees.



Remaining net income after paying all operating expenses will be placed into Capital Reserves General Fund. Maintaining healthy reserves are important for the long-term viability of our neighborhood.

The Board is looking forward to a great year. Our new property manager is diligently working to help us improve our neighborhood. We would love to have more activities to help bring us together, but we need volunteers. If you have some time and talent to volunteer please consider joining the Social Committee or Community Watch.

When will it End?

This is a question we have all asked ourselves when we think about the North Carolina Department of Transportation (NCDOT) and road construction around our neighborhood. Don't forget to add the Piedmont Triad International Airport Authority (PTI) in that thought also, after all they are the people behind the construction of the new bridges and the rerouting of Old Oak Ridge road. After speaking with NCDOT and contacting PTI to no avail, here is the information that I gained in regards to the road situation.

The Urban Loop from I-40 to I-85 South is now open giving us a straight shot from Bryan Blvd. to I-40 south of Greensboro just a hair north of Replacements Ltd. on I-40. That means we will be able to go from the airport and by pass Greensboro, while intersecting with Friendly Ave., I-40, Guilford College Road, Wendover Ave., I-85 south, Highway 220 south, Highway 421 south, Elm Street, Randleman Road, and intersecting with I-40.

The Old Oak Ridge Road bridge is scheduled to open at the end of summer '08. At that time the remaining off ramps to Inman Road will be closed, making it a cut through from Old Oak Ridge Road to Fleming Road. The new off ramps from Bryan Blvd. will give us access to our neighborhood via Old Oak Ridge Road. That means no more exiting onto Fleming Road from Bryan Blvd. and having to cut through the neighborhoods.

Fleming Road will start a make over as soon as the Old Oak Ridge Road bridge is opened. It is going to become a four lane road from Bryan Blvd. to Pleasant Ridge Road to make room for new traffic attributed to new residential and business development.

So hang on friends we still have a ways to go before all of the dust settles.

Changing Times

It is with great pleasure that I introduce myself as your new Association Manager. As an eight-year resident of River Hills, combined with nine years of experience in the field of real estate, mortgage lending and homeowner association management, I am thrilled and honored to have been selected as your new Association Manager. I bring a strong commitment to providing support, service and professional guidance to our Association as we navigate through the changing environment of annexation as well as today's challenging economic times and real estate market.

Along with the ongoing road construction and changes to our traffic patterns, we face another major change this year through the annexation of our neighborhood by the City of Greensboro. Annexation will impact River Hills in several ways. Improved street maintenance will be one of the benefits. This **may** extend to asphalt maintenance on the private streets of River Hills as well. The City of Greensboro currently has a program for providing asphalt maintenance on private streets within the City that meet certain criteria and specifications. While the streets will remain private, we are petitioning the City for asphalt maintenance services on these streets. The process will include verification that the streets were built according to public standards (determined by core samples to determine thickness) and meet other criteria such as width (for access by paving equipment), percentage of on-street parking, and current condition of the streets. While it is possible that some maintenance of these streets may be required to bring them up to the City's standards, the long-term result will be a major savings in funds needed for ongoing maintenance of the private streets. Nothing would change other than the responsibility for asphalt maintenance being transferred to the City by granting a surface easement.

There will be other changes as a result of annexation, many of which will also impact both the Association and our personal budgets. Curbside trash, recycling, appliance and yard waste pick-up will be provided by the City. The rates we pay for water will drop by one-half. The current expense for street lighting should change. While as individuals we clearly will pay more through city taxes (the current City tax rate being 63.5 cents per \$100 of property valuation), some of this increase will be offset by the reductions in cost of trash pick-up and water rates. The overall impact on the Association's budget will be reviewed in the Fall when the normal budget review process begins.

It is the Association's responsibility to preserve, protect and enhance the value of every home within the River Hills community. My goal is to guide the Association through the changing times of annexation and growth of the area that surrounds us. I look forward to a long and mutually rewarding relationship with River Hills. My commitment to this neighborhood is strong, and I welcome your comments, input and questions. With Spring just around the corner, many homeowners will begin thinking about home improvement projects. The Architectural Review Committee is charged with approving projects within River Hills in order to maintain an adequate level of uniformity and an overall appealing appearance within our neighborhood. The committee consists of four volunteers who dedicate their time and efforts to careful review of each request. Following is a partial list of projects that require advance approval: Storage sheds, fences, home additions, driveways extensions or aprons, decks, landscaping projects that alter grade or slope of the yard, retaining walls, painting that includes color change, vinyl siding. Remember, when in doubt...submit a request! Allow 30-days for the review process by submitting your request to Priestley Management 30-45 days in advance.
